- CONFIDENTIAL INFORMATION & NON COMPETE. Both parties agree not to disclose to third parties any proprietary or confidential information (including, but not limited to, pricing and login information). - PRICING. Gunsmith pricing is 20% off MAP plus shipping . Tiered Dealer pricing is based on quarterly volume. If the dealers tiered pricing changes, you will be notified immediately by an H.B. Tactical Accessories representative.
- DEALER ORDERS: Dealers agree to maintain a minimum purchase volume of US \$7,000.00 annually, with a minimum individual purchase amount of \$250.00. The dealer's initial order must be a minimum of \$250.00 (before shipping costs), and be placed within 30 days of becoming a dealer.
- PAYMENT: Payment must be made before shipment of product. Contact account representative at sales@hbtaac.com or 484-949-2987 for available payment options. There is also a \$35 NSF FEE for returned payments.
- SHIPPING: All shipping is F.O.B. H.B. Tactical Accessories facilities. Dealer is responsible for all shipping costs (shipping fees plus additional USPS insurance over \$50 to cover actual product value), taxes, duties, and adhering to Dealer's local customs laws and restrictions.
- DEALER is responsible for providing a VALID shipping address and confirming the shipping address for each order PRIOR to shipping. Any claims for damage to products/orders via shipping process will be routed through the USPS insurance and will not be paid out until USPS releases the funds.

- WARRANTY: All Compensators carry a limited lifetime manufacturer's warranty against defects.
